Safety Measures for Physical Validation Processes

Requirements:

- Committees must adhere to all city, county, and state regulations as set forth by these entities.

Strongly Recommended Best Practices:

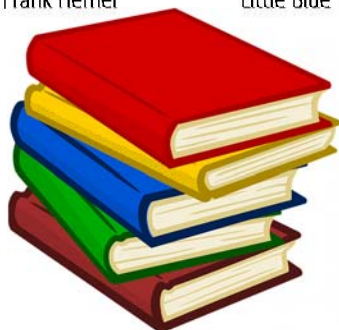
- Work environments should operate with the absolute minimum personnel necessary for the specific task.
- No more than 10 people should be present and out of vehicles at any given time.
- Set 6 feet markers for human traffic on the premise.
- Supply alcohol-based hand sanitizer of at least 60% alcohol at every workstation and at entry/exit points.
- Distance workstations as to separate various task stations as possible, including paperwork, tagging, DNA, etc.
- Encourage at-risk family members/committee members to avoid validation, if possible. At-risk individuals include adults aged 65 years or older, those with asthma, high blood pressure, diabetes, obesity (BMI of 30 or above), heart conditions, or other chronic diseases. For more information, please [visit CDC.gov](https://www.cdc.gov).
- Assign and enforce consistent job responsibilities for each step in the validation process in an effort to avoid multiple people touching the same equipment.
- The state-level county validation committee should plan on the entire validation process taking longer than previous years and should schedule validation dates and times accordingly.
- Disinfect equipment before and after use with a disinfectant registered for use against SARS-CoV-2. Please follow all manufacturer label directions for safe, effective use.
- Encourage PPE (including cloth masks) be worn by validation committee.
- Encourage PPE (including cloth masks) be worn by all exhibitors/family members/participants attending physical validation.
- Ensure that all handwashing stations on premise are functional and supplied with soap and paper towels.
- Allow for paperwork and materials to be brought to the family's vehicles for overview to allow the persons to remain in vehicles until the time their individual livestock is in place to be validated. Only at this time should persons exit the vehicles to witness and sign documentation.
- The state-level county validation committee should offer multiple validation dates to reduce numbers of people gathering on site.
- This should include scheduling system to all scheduled times for each family in an effort to reduce the numbers of people gather on site at a given time.
- The state-level county validation committee should also be prepared to check trailers before pulling into facility to limit people/ trailers on grounds at the same time.
- Hang signage around premise to reinforce safety measures. These include but are not limited to: signage related to washing hands thoroughly for at least 20 seconds at all handwashing stations, maintaining social distance of at least 6 feet, etc.

Texas 4-H Horse Show

We are very excited to announce that the State 4-H Horse Show will proceed at the Brazos County Expo July 19-24! Entries will be open on 4-H Connect June 4th to July 1st. Social distancing requirements have led us to some necessary modifications, but we are looking forward to seeing everyone and celebrating the progress of our youth in the 4-H Horse Project. As we all know, the situation we're in is ever-changing, so we appreciate your patience as we all do our best to make this event happen. If you have any questions please don't hesitate to reach out and as always, thank you for all that you do!

Show modifications to expect

We anticipate that this list will grow as we delve into planning and as mandates change over the coming weeks. Below are the modifications that have been made thus far.

- Due to the cancellation of some district shows, the district show qualification for the State 4-H Horse Show has been waived for this year. Any 4-H youth with a validated horse can enter the state 4-H horse show this year.
- Due to social distancing mandates, there will not be a trade show, nor dance at the show this year.
- Gates will not be used as obstacles in Trail, Stock horse Trail, or Hunt Seat Versatility this year.

Show Schedule

A tentative show schedule is available below. Please note that we may need to adjust slightly to meet facility capacity mandates depending on show entries. Any necessary changes to the schedule will be communicated.

Rules

All changes to the rulebook are designated in red text. Please encourage exhibitors to review the rules carefully before competition.

Validation Refunds

Exhibitors who would like to request a validation refund may do so using the link below. Refunded validations will make that horse ineligible to be shown at the district and/or state 4-H horse shows this year. Refund requests MUST be submitted within 100 days of the invoice date on 4-H connect. Those families that validated early in March will be quickly approaching this deadline so please encourage them to submit their requests quickly. The validation refund request deadline is July 1st.

We are thrilled that we will be able to proceed with the show in person; however this situation has put us behind in soliciting sponsorships. If you know of someone in your community that would like to support the State 4-H Horse Show, please share our sponsorship letter which you can access using the button below.

Join us on social media for Judging in June! We will post a video class of 4 horses each Monday from June 1st through June 22nd. Youth 18 and under can record a video of themselves giving a set of reasons on the class, then submit that video. AUGUST 2020 TRANSITION

THINGS TO KNOW

- 4HConnect will be offline for maintenance August 1-14, 2020.
- 4HConnect will be renamed 4HOnline on August 15, 2020.
- 4HOnline will look different when enrollment opens on August 15, 2020. Family profiles, member profiles and login credentials will stay the same.
- 4HOnline is mobile friendly and easy to learn.
- 4HOnline will have better accessibility options.
- 4HOnline has major improvements in the payment, search, training, communication and report areas.
- Training will be provided throughout July for Extension offices. These trainings will be provided by the 4HOnline programmers.
- Families will have to re-enter credit card information in 4HOnline.
- Horse and dog validation information and photos will need to be re-entered in 4HOnline during the appropriate time periods for the 2020-2021 4-H Year. (does not affect this 4-H year)
- Extension employees who have a county, district or state manager account and a family account sharing the same email address will need to change one. See handouts on making that change.
- With any new program there will be issues to work out. The time period between August 15 to September 1 will be used to work those out.

July 1-31	Online trainings offered throughout the month
July 1	Club charter application deadline
July 15	Club charter applications must have approved status for August 15 enrollment. All other applications will be removed from system. (See August 18)
July 15	Close of all events to allow for payments to arrive (some exceptions)
July 31	Payments for all animals, enrollment and events need to be received
July 31	Adult and youth member profiles must be Active for 2019-2020.
July 31	Last day to do anything in 4HConnect
August 1	4HConnect closes to ALL logins
August 15	Family help sheets and videos available online
August 15	4HOnline will open for the 2020-2021 4-H enrollment year. A youth that is 8 years old and going into the 3rd grade must wait until September 1st to enroll for correct fees to be charged.
August 15	Events can be setup by district and state offices
August 15-31	Texas 4-H will work through issues before new 4-H year officially starts
August 18	Club charter application re-opens on 4HOnline for submissions again.
September 1	New 4-H year officially begins
